You have the right to request a hearing before the court to dispute the garnishment because of claimed exemptions. To obtain a hearing you must appear in the office of the Clerk of the Circuit Court, at the address indicated above, before the summons return date, or on the return date as specified on the summons, before \_\_\_\_\_ a.m. The Clerk of the Court will assign a hearing date, and provide forms which must be prepared, by you or your attorney, a copy of which must be sent to the judgment creditor, and the garnishee and/or their respective attorneys.
