NOTICE TO PLAINTIFF: Through August 24, 2020, Section 4024 of the Coronavirus Aid, Relief, and Economic Security (CARES) Act prohibits filing certain evictions from “covered dwellings” if those dwellings are in “covered properties.” A “covered property” is any property that receives a federal rental subsidy or has a federally-backed/insured mortgage (such as Fannie Mae, Freddie Mac, or the FHA). A covered property is any property that:
 - a. participates in -
 - i. a covered housing program (as defined in section 41411 (a) of the Violence Against Women Act of 1994 (34 U.S.C. 12491(a))); or
 - ii. the rural housing voucher program under section 542 of the Housing Act of 1949 (42 U.S.C. 1490r); or
 - b. has a -
 - i. Federally backed mortgage loan; or
 - ii. Federally backed multifamily mortgage loan.
