## **INTRODUCTION**

Various and numerous changes have been implemented recently in order to allow tax valuation objection cases to proceed. Some of these changes are procedural and affect the scheduling of 2017 and prior tax year cases during the continuing COVID-19 pandemic, but some of these changes are more structural, as with the new system for case management beginning with the 2018 tax year cases. This document will summarize these changes, and provide citations and links to Administrative Orders which have been entered by the County Division in order to implement these changes. There have also been two Memos circulated by the Court (dated August 31, 2020 and September 4, 2020), the substance of which are also incorporated herein.

This guidebook is divided into 3 sections – Section 1 dealing with recent changes affecting cases for tax years 2017 and prior; Section 2 dealing with recent changes to case management for cases beginning with tax year 2018; and Section 3 providing resources for all tax years. These changes have come about as the result of many hours of work and cooperation by and between various agencies and individuals, including members of the judiciary, the Clerk of the Circuit Court’s Office, the Cook County State’s Attorney’s Office, the Cook County Treasurer’s Office, the Circuit Court Rule 10.8 Committee, and the practicing bar. ## **SECTION 2. Cases for tax year 2018 and after**

### **A. BRIEF EXPLANATION OF NEW PROCEDURES**

1. All 2018 cases will be assigned to one of nine individual calendars;
2. For each individual calendar's case management call, Orders (Small Claim, Case Management, or Dismissal) are to be electronically submitted ahead of the scheduled case management date. No personal appearance at a case management call is required or desired, but if a personal appearance or conference is necessary, the parties shall jointly request a Zoom conference. See Administrative Order 2020-7 on how to request a Zoom conference;
3. If the case is a regular track case requiring the entry of a Case Management Order, the dates contained therein will continue to be determined pursuant to section 2-34 of Rule 10.8 (see grids, attached Exhibit 2), except that there will no longer be the need to include a provision for the assignment of the case to a trial judge. Parties may continue to request alteration of the dates as calculated under section 2-34 by following the requirements of section 2-34(b);
4. Circuit Court rules 10.6 and 10.8 are being revised to conform to these new procedures.
