Motion to Vacate & Expunge Eligible Cannabis Convictions

Name of forms:	<ul style="list-style-type: none"> • <i>Motion to Vacate & Expunge Eligible Cannabis Convictions</i> • <i>Notice of Motion to Vacate & Expunge Eligible Cannabis Convictions</i> • <i>Order to Vacate & Expunge Eligible Cannabis Convictions</i>
Purpose of the forms:	To get a court order vacating and expunging eligible cannabis conviction(s) under the Cannabis Regulation & Tax Act .
Types of cases the forms CAN be used for:	Misdemeanor and Class 4 felony convictions for Sections 4 and 5 of the Cannabis Control Act .
Types of cases the forms CANNOT be used for:	<ul style="list-style-type: none"> • Arrests or convictions for other non-cannabis offenses. • Arrests or other cases not leading to conviction for a cannabis offense. • Convictions for Class 3, Class 2, Class 1 or Class X Cannabis offenses. • Out of state and federal cannabis conviction records.
Cost to file the forms:	There may be a fee to file your <i>Motion to Vacate & Expunge Eligible Cannabis Convictions</i> . If you cannot afford to pay the filing fee, you can ask the court to file for free or at a reduced cost by filing the <i>Application for Waiver of Court Fees</i> found at: illinoiscourts.gov/documents-and-forms/approved-forms .
Special information or papers needed to complete the forms:	<ul style="list-style-type: none"> • Dates of arrests and class of misdemeanor or felony charges; • Outcome of court cases: AND • Addresses of the county State's Attorney's office that filed charges against you.
