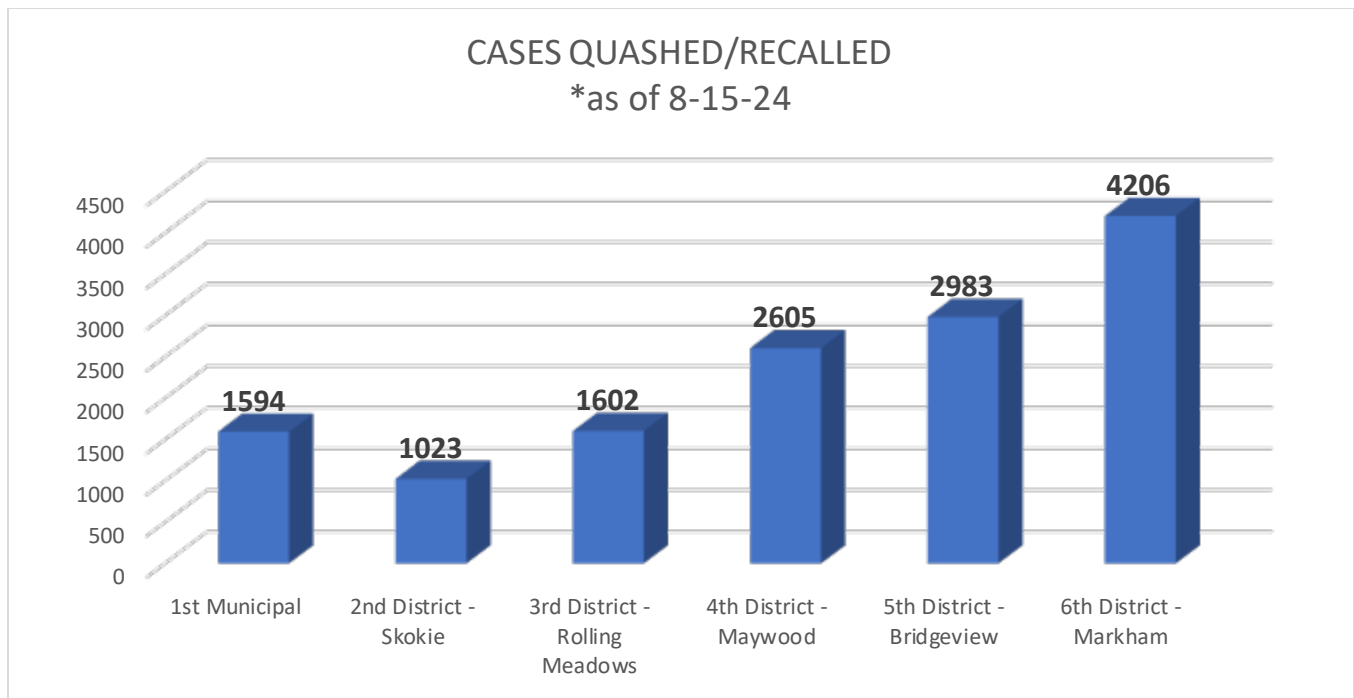


## Misdemeanor Warrants (Safety and Justice Challenge Project)

The Clerk of the Circuit Court of Cook County is pleased to announce our participation in Cook County's *Safety and Justice Challenge (SJC)* initiative on misdemeanor warrants reduction. The goal of this project is to address older non-violent misdemeanor active warrants throughout the various judicial districts in Cook County.

As part of this initiative, litigants/defendants need not be present in court and will not be required to complete any court filings. Staff from the appropriate county offices will examine qualifying cases and proceed with the legal steps to file a motion before a judge to address selected cases.

As of August 15<sup>th</sup>, 2024, over 14,000 cases have been "Quashed/Recalled" (QR)\*. The graph below illustrates the number of cases addressed by judicial district.



*\*Quashed/Recalled is the legal term for de-activating a warrant. Law enforcement agencies do not have the authority to detain defendants and/or bring him/her to court.*
